However, while it obviously brings in huge revenues to a destination, sex tourism also degrades country reputation, position and impacts on its culture at the same time. Although most people have heard of sex tourism, not many can differentiate normal tourists from sex Concerned tourists. The broad nature of the term "sex tourist" can be defined; "anyone who is open to and desires for opportunities for sexual contacts or sex knowledge" can be considered as a sex concerned tourist. Often times, it is awkward for a person to declare oneself as a sex-concerned tourist because sex tourism is still both illegal and immoral in many countries.

Sex Tourism has been systematically tined by many academics researching within the orbit of sex tourism that to define / understand the happening which is in short of impossible. Ryan and Hall (2001) recommends that to define it simple as any tourist excursion where the primary motivation of the trip is to have sexual relations with somebody is an oversimplification of a very complex interact.

O'Connell Davidson takes out motivation from the definition, insist that we might conceptualize sex tourism as the activity of individuals who 'use their economic power to attain powers of sexual command over local women, men and/or children while travelling' (1998: 75). In different areas of the world – and sex tourism in its multitudinous forms takes place globally – there are very different trends and patterns in the types of sex tourism that go on.

#### CONCLUSION


